S18 of the Return to Work Act – A Review of the New Landscape

The impact of the Return to Work Act 2014 (SA) on employers as we reach 4 years since the commencement of the Act.

Section 18 of the Act provides that the employer of a worker who has been incapacitated due to a work injury must provide suitable employment to that worker unless it is not reasonably practicable to do so. As a result, we have seen a significant increase in the number of applications to the South Australian Employment Tribunal for the provision of suitable employment with the pre-injury employer.

During this seminar, Patrick Walsh will discuss a number of cases concerning the interpretation of aspects of section 18, some of his experiences at the Tribunal and the lessons that can be drawn regarding these applications.

Tony Matkovic and Harry Tsekouras (ProActiv People) will also provide an overview of the best practices that employers can engage to successfully rehabilitate injured worker's within the new timeframes imposed by the Act, which can also help reduce an employer's premium.
