## COVID-19: Retail and Commercial Leasing **Emergency Relief Extension**

Tenants who have been affected by the COVID-19 pandemic and associated restrictions have been able to receive legislative relief through the COVID-19 Emergency Response Act 2020<sup>1</sup> ('Act') as well as the COVID-19 Emergency Response (Commercial Leases No 2) Regulations 2020<sup>2</sup> ('Regulations'). The Act and Regulations relating to commercial leasing are due to expire on 30 September 2020, but the State government is now considering extending the regulations from 1 October 2020 through to 3 January 2021 due to the ongoing impacts of COVID-19.

#### Dispute resolution assistance extended in South Australia

On 8 September 2020, the Small Business Commissioner announced that the State Parliament will consider amendments to extend the Regulations in relation to commercial leasing disputes until 3 January 2021 with an option to extend it further if necessary.

The amendments (if passed) will allow the following key leasing principles to continue:

#### 1. Negotiating in good faith;

- 2. Mediating through CBS (if necessary);
- 3. Determining a dispute through the Magistrates Court (if negotiation / mediation fails).
